NATIONAL RALLY AT GLEN ROSE, TEXAS  
EXECUTIVE COMMITTEE MEETING  
OCTOBER 7, 2021**

Elaine Jackson, President, opened the meeting.

Members present were Elaine Jackson, Dixie Hines, Terry Hines, Betty Jones, Jim Westphal, Crystal Jackson, Carolyn Carter, Trish Rowe, Rev. Steve Rowe, and Bryant Carter.

Elaine reported the membership seems to be holding steady but she noted that our membership is getting older and younger people do not seem interested as they have work and family obligations so they prefer to camp on their schedule. According to the Membership Report filed, we have 139 memberships as of August 1, 2021.

The Presidents Committee recommends that a rally be held in 2022. They suggested that the Executive committee choose a centrally located place and report to the membership through the National Newsletter and to Chapter Presidents via e-mail.

The Executive Committee discussed holding the 2022 Rally in Memphis, TN, Nashville, TN, Kentucky and Branson, MO. The Committee voted to try for Branson, MO, in October of 2022. Terry Hines volunteered to locate a park and confirm dates to have the rally. The Committee approved changing the days of the rally from Wednesday through Sunday to Monday through Friday, to accommodate an RV Park and to get the best price. To keep it simple each membership family will make their own reservation; bring a snack to share at the rally and a door prize to cost about \$20. Entertainment will be up to attendees from all the choices at Branson. The group will attend a local restaurant for the meals. The required meetings can be at a facility at the campground or a restaurant or a local church. The details will be passed on to the membership through the Chapter Presidents and printed in the National Newsletter.

There was a discussion regarding the changes to the website and should we keep it or use Facebook. The vote was to keep the website. Currently the cost is \$300/year. Terry Hines will make the change to the new website and he requested that the Chapters give him correct and current information to post, including chapter officers and meeting schedules.

Dixie Hines (Second Vice President) will become First Vice President in 2022 and hold the 2023 Rally in Texas as President. Currently we need to fill the President and Second Vice President positions for 2022 and the 2024 Directors position.

Crystal Jackson, Publicity Secretary, asked permission to change the National Newsletter publication dates to January, April, July, and October. All information will need to be into her by each preceding month. Changing the dates will coincide better with our Fiscal Year. A motion was made, seconded and approved to change the publication dates of the National Newsletter.

Crystal wants more Chapter information for the newsletter. She asked the Chapter Presidents to notify her of any information to be printed in each quarterly National Newsletter; one month prior to each publication date, including their upcoming campouts for that quarter.

Crystal, as National Historian, asked what to do with the paper records of the National Newsletter for years 2006 – 2021 after they have been recorded on an electronic format. After a discussion, Terry Hines made a motion to give the National Historian permission to maintain the Historians records electronically. The motion was seconded and approved.

Crystal has on display photos of past rallies. She does not have pictures of all of the rallies and asked for help to find those missing pictures so the records can be complete. It was suggested that she post her request in the National Newsletter to see if anyone has what she needs.

The President received boxes of items that she did not use and they have not been used at rallies for several years. There is no need to pass these items on to carry and store. She would like help sorting these items and keep what is useable to the NUMC and get rid of the rest. The Executive Committee agreed that Elaine should appoint a committee to sort through the items and decide which items should be kept, donated, or destroyed.

President, Elaine Jackson, adjourned the meeting.

COUNCIL OF PRESIDENTS MEETING  
OCTOBER 7, 2021**

Elaine Jackson, President, opened the meeting.

Members present were Mike Stumbaugh, Martin Reynolds, Jim Westphal, Trish Rowe, David Houghtalen, Dixie Hines, Terry Hines, Elaine Jackson, Betty Jones, and Bryant Carter.

President, Elaine, asked how the Chapter membership was doing. Chapter 16 is going good. Some of the others only have 4 to 5 rigs at a meeting.

Because Missouri cannot hold the 2022 National rally, Elaine asked if we wanted to hold a rally in 2022 or not. The consensus of the Presidents Committee is we should recommend to the Executive Committee that we should hold a rally in 2022.

A discussion followed as to where to hold it and what the particulars of the rally should be recommended to the Executive committee.

1. It should be held at a central location for the majority of the chapters; i.e. Branson, MO, Gadsden, AL, Nashville, TN
2. Keep it as simple as possible.
3. Meals could be at local restaurants.
4. Entertainment could be provided by local churches.
5. Door prizes and snacks should be provided by those attending.

Dixie Hines, noted that the current web site is going to change in December and Terry Hines, National Coordinator, will have to change over all the information. She questioned if we should continue with the web site, the current cost is \$300/year. We discussed using Facebook instead. After a discussion the Committee voted to inform the Executive Committee to keep the web site.

ANNUAL MEMBERSHIP MEETING  
OCTOBER 9, 2021**

Elaine Jackson, President, opened the meeting.

Invocation was given by Rally Chaplain, Rev. Steve Rowe.

President Jackson recognized the past presidents in attendance, Bryant Carter, Dixie Hines, David Houghtalen, and Terry Dykman.

The National President gave her report. We have 51 members attending, 22 rigs on site, 2 cabins rented and 3 members staying off the campground. Six members could not make it.

The New York Chapter (Dave Houghtalen and Debbie Williams and Clair and Betty Jones) traveled 1610, the most miles to come to the rally.

The donation to Aldersgate Enrichment Center, the 2021 Mission Project, was just under \$800.

The following reports were printed in the Rally Booklet for the members to review prior to the meeting, 2019 Annual Membership Report, 2021 Treasures Report, 2021 Member Secretary Report and 2021 Store Keepers Report. The President asked for a motion to accept the reports as printed in the booklet. A motion made by Bill Marsh, seconded by Trish Rowe and approved by those present.

Membership Secretary, Harold Darling, reported that better communications are needed between the Chapter Officers and the web management. The official NUMC reports are on the website in PDF format for preferred use by the membership.

For clarity, Harold Darling went through the steps to disband a chapter. The chapter must hold a meeting with their membership. The chapter must vote to disband and to turn in their Charter. This must be recorded in the minutes. The chapter decides how to dispose of any funds still in the treasury as they must have a "0" balance in their treasury when they disband. The meeting minutes and the "0" balance Treasurers Report are to be forwarded to the Membership Secretary. The members have a choice of just dropping out of the NUMC or join another chapter (notify Member Secretary) or be a member at large where they send in their own dues.

National Secretary, Betty Jones read the 2021 Executive Committee minutes. A needed correction was asked by Terry Hines. His motion should read "I make a motion to give the National Historian permission to maintain the Historians records electronically."

Dixie Hines commented that the Executive Committee minutes indicated that the national rallies are held 5 days, but actually it is only 3. There was not a motion to correct that.

A motion to approve the 2021 Executive Committee minutes, with the correction was made by David Houghtalen, and seconded by Dixie Hines. The motion carried.

To clear up Newsletter information, Crystal Jackson, Publicity Secretary, said the next National Newsletter will be out the first week in January. She must receive all information by the 15<sup>th</sup> of the previous month, December. She will have the next deadline for information in bold as a reminder.

The completed newsletter is sent electronically to Terry Hines, who sends it to the Executive Board and Chapter Presidents. The Chapter Presidents are to distribute the newsletter to their membership.

The National Historian, Crystal Jackson, reminded everyone that she has photographs of the rallies for everyone to look at. Contact Crystal if you have pictures to add to the collection.

Harold Darling, Membership Secretary, needs correct contact information for each chapter. The list, in chapter order, is there for you to verify or to correct the information.
